All the very best for 2018 which already seems to be a good year coming for South Africa.

This form needs to be filled in by owners, tenants, domestic workers and even possibly pool and garden services - the attached gives full details.

On a different note, please note that due to a physical mis-sort whilst I updated the software on my computer, we lost the Database that was up-to-date as at October 2017.

Over the past two months I have endeavored to reconstruct the database to include as much amended information that has been passed on in the last Quarter, but we may still be incorrect in certain instances, and I truly apologize for any inconvenience caused by this mishap.

To this end, please share this important NEWSFLASH with your neighbors so ensure that everyone is aware of the new developments, and if anyone you know has not received this email, please let me know their name, address, email and mobile details soonest so we can rectify the error.

Another two quick snippets of local importance is that building of the WOODMEAD RESERVOIR is due to commence in April/2018 on the site next to the Woodmead Garden Refuse Dump. This will eliminate the problems we experience with that open ground which currently serves as a latrine for all and sundry as well as a home for vagrants where the rubber casings are also burnt off stolen copper cabling - hence the smell that hits us every so often at night.

The second issue is that various businesses within Woodmead are considering creating a WOODMEAD C.I.D. (City Improvement District) which will stretch from approx. the Cedar Park Hotel in Western Services Road to the Buccleuch Interchange, taking in all businesses therein including Makro, Pro-Shop, Woodmead Retail Park, etc. How far west this will stretch is not yet determined but there will be community meetings and involvement in this regard. We will keep you advised as developments occur and are meeting with the relevant parties 2<sup>nd</sup> week February to find out more about this proposal.
