Watering holes —R5 000 each "Closest to the Pin"

(Rocklands Holes #4, #8, #13, #15)

This sponsorship offers facilities at four different holes on the golf course situated at the Par Three's where historically short delays are experienced. These are perfect spots for promoting your image and providing liquid refreshment to all golfers coming through.

Additional drinks can be ordered on the day and will be available at additional cost for the sponsors' own account. Please note that no alcohol will be allowed on the course.

CCJ will provide the following standard equipment to each watering hole: two chairs, a table, tablecloth and ice.

These Par Three's also provide for 'Closest-to-the-Pin' competitions (unisex) and you are able to donate an additional sponsor-specific prize in this regard.

Four Ball Entry - R3 000 (only 24 available)

Halfway House, caddy fees (R160) and caddy lunch voucher (R35), golf carts (R260 for two persons) are for the players account.

A CASH BAR will operate after the game and at the Prize Giving cocktail function on the terrace.
